Title of document

Brentwood Local Plan 2016 - 2033 (Pre-Submission, Regulation 19), January 2019

Subject matter and area covered

The Local Plan sets out the vision and framework for guiding development within the whole of the Brentwood Borough up to 2033. It identifies the number and locations for new homes, jobs and businesses being planned for; what infrastructure is required to support them; and the areas that will be protected from development. It also contains policies that the Council will use to determine planning applications.

Period of publication for representations

Representations are invited on the Local Plan and its supporting documents for a period of 6 weeks, from Tuesday 05 February 2019 and ending at 5pm on Tuesday 19 March 2019. Any representations received after the consultation has closed will not be considered. Postal addresses must be provided. This statement provides further details on how to make representations.

Representations should focus on whether the Local Plan is legally compliant and whether it is considered to meet the Tests of Soundness, as specified in the National Planning Policy Framework. Those making a representation should also state whether they would like to speak at the independent examination.

Representations may be accompanied by a request to be notified at a specified address (postal or electronic) of any of the following:

- 1. The submission of the Local Plan to the Secretary of State for independent examination under Section 20 of the Planning and Compulsory Purchase Act 2004;
- 2. the publication of the recommendations of the person appointed by the Secretary of State to carry out the independent examination; and
- 3. the adoption of the Local Plan by the Council.
