Types of properties	Barnston Way is a new development comprised of 3 properties of which 2 are properties that can be adapted.			
	For this reason the allocation of the properties will be targeted at those households on the transfer list and waiting list who require an adapted home.			
	Secondly if households who are registered on the transfer list or housing register do not bid for the properties, the properties will be available to those households on the transfer list who will release larger social housing accommodation in the Borough.			
	Where a transfer applicant releases a larger social housing property they will be entitled to a payment under the Council's under occupation scheme.			
Properties to be let on a "direct let" basis	The properties will be let directly by the Council to ensure that the properties are allocated who are most in need of adapted properties and who will also be able to release much needed family sized accommodation.			
Priority Applicants – First Group	Transfer Applicants that have been refused Aids & Adaptions in their current property			
Priority Applicants - Second Group	Transfer Applicants that require an adapted property due to medical need.			
Priority Applicants – Third Group	Housing Register Applicants that require an adapted property due to medical need.			
Priority Applicants - Fourth Group	Transfer Applicants that are downsizing and will release a larger property by moving.
